- 2) Put the AADHAR NO. in the field provided for the same.
- 3) The candidate will receive an OTP (One Time Password) in their registered mobile no.
- 4) Photo to be captured by the in the mobile by the candidate herself.
- 5) The rejected application form to be resubmitted online by the candidate.
- 6) All the non-enrolled nurses for NRTS may be advised/ directed to enroll into NRTS and to authenticate by using AADHAR linked OTP and to upload the photograph.

**Sub:- Implementation of Nurses Registration and Tracking System (NRTS)  
Authentication of Nurses based on Aadhar Authentication regarding.**

Sir/Madam,

This has reference to the ongoing NRTS implementation at your Council. Till now the authentication of nurses was done by using biometric finger print scanner based on UIDAI issued Aadhar number. You are aware that this biometric finger print scanner was available only with SNRC, at times it was giving technical problems, because of which the self-enrolled nurses were not able to get proper appointment with SNRC for getting their biometric authentication and photo capturing at SNRC. Therefore INC in consultation with NIC and UIDAI has decided that authentication can be done by OTP on mobile linked with Aadhar number. This has made operational in a NRTS website and same has been made available operational for self-enrolling Nurses, SNRC (Suptd. Login) Nursing and Institutions/Colleges/Schools.


It is observed that there are 566 self-enrolled Nurse are awaiting for authentication purpose at your Council. You are advised to return/reject the Nurses data with the comments "The authentication can be done based on OTP linked with Aadhar after that you can make resubmit".

Further you are also requested to publicize that all the non-enrolled nurses into NRTS may be advised/directed to enroll into NRTS and Authenticate by using Aadhar linked OTP and upload the photograph. After that SNRC can verify and approve the data for generating NUID number.

Once again, I request your active cooperation making the live Register of Nurses a reality.
