All the Reciprocal Registration candidates are hereby being informed that as per Indian Nursing Council notification **no. 1-6/(LT)-2023-INC, Dt. 08.06.2023** it is clarified that the candidates who have got admission in **B.Sc. (Nursing) course on 2023 & onwards** shall be admitted only if they qualify in the entrance exam conducted by State Government / University / State common entrance cell.

In case admission are resorted to with the concerned students not passing or appearing in the combined admission test conducted for the purpose of admission to B.Sc. (Nursing) course nor following the guidelines for admission prescribed by the Indian Nursing Council, such students' reciprocal registration application could not be accepted in the West Bengal Nursing Council. It should be also noted that candidate must keep their rank card / result of the entrance examination which should be needed during reciprocal registration verification. **This notice will be applicable from 2023-2027 B.Sc. (Nursing) batch & onwards.**

In case admissions are resorted to with the concerned students not passing or appearing in the combined admission test conducted for the purpose of admission to B.Sc(N) course nor following the guidelines for admission prescribed by the Indian Nursing Council, such students will be liable to face problems in **RECIPROCAL REGISTRATION**.

All Universities, SNRCs and nursing institutions are required to strictly abide by the above notification.
